3.1 Confession text

What you type in the form (category + message). We do not ask for your name or email.
Purpose: moderation and public display if approved.
Storage: server files on your hosting; copy sent to the moderator via Telegram.

3.2 IP address (anti-spam)

Your IP may be stored briefly to enforce a posting rate limit (about one post per
5 minutes per IP).
Purpose: spam prevention.
Retention: timestamps in a server file; not tied to published posts.

3.3 Language preference

The site may store your language choice in your browser (localStorage key: hnj_lang).
Purpose: remember UI language.
No account is created.

3.4 Server and security logs

Your hosting provider may log IP address, browser type, date/time, and pages requested.
We do not control those logs. Check your host's privacy policy.

3.5 Donation links (if enabled)

If you click an external donation link (e.g. Ko-fi, Buy Me a Coffee), that third party
processes data under its own policy. We do not receive payment details on this site.

4. ANONYMITY - PLEASE READ CAREFULLY

We do not collect names or accounts, but complete anonymity cannot be guaranteed.
Moderators, hosting providers, and authorities may in some cases identify users
(e.g. via IP logs or legal requests). Do not post information that could identify
you or others if that matters to you.

We do not sell personal data.
